The \$10,000 grant we received has been fully spent at this time. As promised, the funds were used to pay a portion of the pre-development expenses for our facilities renovation and expansion plan. The grant covered the costs of our site survey (\$1,800), geophysical survey (\$850), stormwater management study (\$2,250), traffic study (\$1,900), sewer line study (\$1,685) and site planner costs (\$2,000).
